AN ACT

TO APPROPRIATE MONEYS TO THE SERVICE OF THE GOVERNMENT

[7th June, 1990]

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:-

1. This Act shall be cited as the 1989-90 Supplementary Appropriation Act. (No. 1) 1990.
2. There shall be issued from general revenue and other funds of the Kingdom and applied to the service of the year ending the thirtieth day of June, One Thousand Nine Hundred and Ninety any sum or sums not exceeding three hundred and fifty one thousand two hundred pa'anga in addition to the amount approved by the 1989-90 Appropriation Act 1989, for defraying the charge of the Government of Tonga for such period in the manner expressed in the Schedule to this Act.
3. The Treasurer shall issue and pay such sum or sums of money for the purposes set out in the Schedule not exceeding in the whole the sums respectively as the Prime Minister shall by warrant under his hands direct.
4. The moneys granted by this Act are intended for the services in respect of which moneys will become payable within the financial year ending on 30th June, 1990 and any balance thereof unused at the end of June 1990 shall lapse and not be available for making payment in any subsequent month.

Passed by the Legislative Assembly this 7th of June 1990.

4. 'Oku fakahangahanga 'a e ngaahi pa'anga 'oku fakangofua 'e he Lao ni ki he ngaahi ngaue pea 'e totongi atu 'a e ngaahi pa'anga ko ia lolotonga 'o e ta'u faka-Pa'anga 'o ngata 'i he 'aho 30 'o Sune 1990 pea ka 'i ai ha toe 'o e pa'anga ko ia 'o 'ikai ke fakahu ki mu'a 'i he 'osi 'a e mahina ko Sune 1990 kuo pau 'e 'ikai ngaue'aki ia mo ngofua ke fai'aki ha totongi 'i he mahina ki mui mai.
