PROCLAMATION

TONGA DEFENCE SERVICES ACT, 1992

(Section 14(3))

DECLARATION OF CESSATON OF OPERATIONAL SERVICE

In exercise of the powers conferred by section 14(3) of the Tonga Defence Services Act 1992,

HIS MAJESTY KING TAUFA'AHAU TUPOU IV

hereby declares that the following units of the Tonga Defence Services which were deployed in the South Pacific Peace Keeping Force (SPPKF) to Bougainville, shall cease to be on Operational Service as from Friday, 4th November, 1994:

- (a) one light infantry company consisting of a composite force of the Tonga Royal Guards and the Royal Tonga Marines; and
- (b) the V.O.E.A. "Pangai" of the Navy.

Given under my hand and seal at the Palace this 18th day of November, 1994.
