**CONSUMPTION TAX ACT 2003**

**(Section 5(3)(a))**

**ORDER**

**IN EXERCISE** of the powers conferred by section 5(3) (a) of the Consumption Tax Act 2003, the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order-

- (1) Imports of project supplies by Fincomm B & R Development Tonga Ltd for the construction of its new commercial complex located at Ma'ufanga, Tongatapu, shall be exempted from consumption tax;
- (2) This exemption of consumption tax shall not apply to the specific import of office furniture by or on behalf of Fincomm B & R Development Tonga Ltd.

**(Section 3(1) (b))**

**ORDER**

**IN EXERCISE** of the powers conferred by section 3 (1) (b) of the Customs Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order -
