ORDER

CONFERRING ENHANCED JURISDICTION

**PURSUANT TO** subsection 11(4) of the *Magistrates Court Act* (“the Act”), I hereby invest Senior Magistrate Loupua Pahulu-Kuli with enhanced power, when hearing and determining criminal cases with the consent of the prosecution and the defendant in accordance with sections 35 or 36 of this Act, to inflict a maximum punishment not exceeding seven years imprisonment or a fine of \$50,000.

Subject to further Order, this Order shall expire on 30 June 2025.
