### CHAPTER 74

# AGRICULTURAL FEES (AMENDMENT) ORDER NO.23 OF 1995

To amend the Agricultural Fees Order No. 27 of 1987.

IN EXERCISE of the powers conferred upon me by section 1 of the Agricultural Fees Act [CAP. 74], I, THOMAS BROTHY FARATIA, Minister of Agriculture, Livestock, Forestry and Fisheries, make the following order: -

#### AMENDMENT OF PART C OF THE SCHEDULE

- Part C of the schedule-to the Agricultural Fees Order No. 27 of 1987 in this order referred to as the "principal order" is amended
  - (a) in column 11 by deleting "800" corresponding to paragraph 12 in column 1 and substituting "2,000";
  - (b) in column 11 by deleting "400" corresponding to paragraph 13 in column 1 and substituting "500";
  - (c) in column II by deleting "1500" corresponding to "Minor surgical operations" in column I and substituting "4,000";
  - (d) in column II by deleting "3500" corresponding to paragraph 14(1)(a) in column I and substituting "10,000";
  - (e) in column 11 by deleting "4000" corresponding to paragraph

    14(1)(b) in column 1 and substituting "12,000";
  - (f) in column II by deleting "2500" corresponding to paragraph 14(1)(c) in column 1 and substituting "5,000";
  - (g) in column II by deleting "500-1000" corresponding to paragraph 14(1)(d) in column I and substituting "1,000-2,000";
  - (h) in column 1% by deleting "2500" corresponding to paragraph 14(2)(a) in column 1 and substituting "5,000";
  - (i) in column II by deleting "3000" corresponding to paragraph 14(2)(b) in column I and substituting "7,000";

- (j) in column II by deleting "1500" corresponding to paragraph 14(2)(c) in column I and substituting "2,000";
- (k) in column II by deleting "500-800" corresponding to paragraph 14(2)(d) in column I and substituting "500-1,000";
- (1) in column II by deleting "4000 vt per hour plus cost of materials" corresponding to paragraph 15 in column I and substituting "10,000 per hour plus cost of materials and drugs";
- (m) in column II by deleting "500" corresponding to paragraph 16 in column I and substituting "1,000";
- (n) in column II by deleting "4000" corresponding to paragraph 17 in column I and substituting "5,000";
- (o) in column 11 by deleting "2000" corresponding to paragraph 18(a) in column 1 and substituting "5,000";
- (p) in column 11 by deleting "2000 plus 20 vt per kilometre" corresponding to paragraph 18(b) in column I and substituting "5,000 plus 30 vt per kilometre".

#### AMENDMENT OF PART D OF THE SCHEDULE

- Part D of the schedule to the principal Order is amended -
  - (a) in column 11 by deleting "1000 plus cost of drugs" corresponding to paragraph 19 in column 1 and substituting "1,500 plus 30 vt per kilometre plus cost of drugs";
  - (b) in column 11 by deleting "1000 plus 20 vt" corresponding to paragraph 20 in column 1 and substituting "3,000 plus 30 vt";
  - (c) in column 11 by deleting "4000 vt per hour plus cost of materials" corresponding to paragraph 21 and substituting "5,000 per hour plus cost of materials and drugs".
