THE IMPORTS OF GOODS (MISCELLANEOUS CONTROLS) ORDER NO.28 OF 1987

An Order to restrict the importation of miscellaneous items into the Republic of Vanuatu.

IN EXERCISE of the powers contained in section 2 of the Import of Goods (Control) Act No. 19 of 1984 as amended by the Import of Goods (Control) (Amendment) Act No. 12 of 1985, I hereby make the following Order:-

RESTRICTION AS TO THE IMPORTATION OF MISCELLANEOUS ITEMS

No person may import into the Republic of Vanuatu any of the goods which are described and specified under the customs tariff headings as set out in Schedule 1 hereto without an Import licence issued therefor by the Minister.

APPLICATION FOR A LICENCE

An application for a licence in pursuance of this Order shall be made in the first instance to the Minister.

An application under this Order shall be in writing and shall contain such information as the Minister may in each case require.

FORM OF LICENCE

- (1) A licence issued under this Order shall be in the form as set out in Schedule 2.
 - The Minister may add to or vary the conditions to which a licence is subject.
