An Order to further amend the Import of Goods (Miscellaneous Controls) Order No.28 of 1987.

IN EXERCISE of the powers conferred by Section 2 of the Import of Goods (Control) Act No.19 of 1984, as amended, I hereby make the following Order:

**AMENDMENT OF ORDER No.28 OF 1987**

1. The Import of Goods (Miscellaneous Controls) Order No. 28 of 1987, as amended is further amended as follows -

(a) by repealing Schedules 1 and 2 and substituting the following Schedules 1 and 2 therefor.


**COMMENCEMENT**
