PORT VILA MUNICIPAL ELECTIONS (REGISTRATION OF ELECTORS AND ELECTORAL ROLL) ORDER NO. 2005 1980

In this Order :-

To provide for the registration of electore and electoral roll for Port Vila Municipal Council elections and matters connected therewith.

IN EXERCISE of the power contained in Section 6 of the Municipalities Act No.5 of 1980, I hereby make the following Order :--

Interpretation.

"the Regulation" means the Joint Election Regulation No. 19 of 1979.

Pereons Eligible to vote. Subject to Claueee 3, 4, 5 and 6, pereons eligible to vote for election of councillers to serve on the Port Vila Municipal Council shall be those person -

- (a) whose namee are contained in the electoral roll for the Port Vila Registration Area established in eccordance with the Regulation; and
- (b) who are resident within the boundaries of the Port Vila Municipality as altered by the Municipalities (Alteration of Port Vila Soundaries) Order No. of 1980.

Registration of New Votere.

- 3. Any person who is not on the electoral roll referred to in Clause 2 but who ~
 - (a) has or will have attained the ege of eighteen (18) years by 15th January, 1981; and
 - (b) has resided within the area of the Port Vila Municipality since before 15th January, 1980;

and who in ell other respects meet the voting qualifications required by Section 10 of the Regulation may apply for his name to be added to the electoral roll.

Application for Registration.

4. Applicationa for registration shall be made in person to the Electorel Registration Officers at the Offices of the District Commissioner in Port Vila.

Commencement of 5. Registration will start on the dats of the signing of Registration. this Order end will continue until 20th January, 1981.

Amendment of Certain Sections of Election Regulation No.19 of 1979. A person epplying for registration shall be required to provide euch evidence of his length of residence within the area of the Port Vila Municipality end his date of birth as shall satisfy the Electoral Committee of the validity of his claim.

A person whose name is added to the electoral roll shall be issued with an electorel identity card.

Subject to Cleuse 11, in accordence with Sections 22 and 23 of the Regulation, the electorel roll for the Port Vila Registration Area -

(a) shall be made available for inepection by the public from 21st January, 1981 to 4th February, 1981, during which period applications for any additions, deletions or changes may be made to the Electoral Committee at the Offices of the District Commissioner; and

(b) shall be setablished by the Electoral Committee.

- 9. Any person who intends to vote in the forthcoming Port Vila Municipal Council election shall be in possession of a valid electoral identity card.
- 10. Subject to Clause 11, in the event of destruction loss or theft of an electoral identity card, the rules governing the issue of a duplicate card shall be those rules contained in Schedule 2 of the Regulation.
