### Declaration of Authorized Game (Money Wheel) Order No. 36 of 2015

In exercise of the powers conferred on me by subsection 40(1) of the Casino Control Act [CAP 223], I, the Honourable MAKI STANLEY SIMELUM, Minister of Finance and Economic Management, make the following Order.

#### 1 Declaration of authorized game

The Money Wheel is declared as an authorised game that may be conducted or played in a casino pursuant to a casino licence.

#### 2 Commencement

This Order commences on the day on which it is made.

#### Honorary Citizenship (Vanuatu Economic Rehabilitation Program) Regulation (Amendment) Order No.37 of 2015

In exercise of the powers conferred on me by section 23 of the Citizenship Act [CAP 112], I, the Honourable HAM LINI VANUAROROA, Acting Prime Minister and Minister of Trade, Commerce, Industry and Tourism, make the following Order.

#### 1 Amendments

This Honorary Citizenship (Vanuatu Economic Rehabilitation Program) Regulation is amended as set out under the Schedule.

"(e) USD 4,000 per annum for due diligence checks"

## Privileges For Honorary Citizenship (Vanuatu Economic Rehabilitation Program) Regulation Order No. 38 of 2015

In exercise of the power conferred on me by subsection 20(1) of the Citizenship Act [CAP 112], I, His Excellency, BALDWIN LONSDALE, President of the Republic of Vanuatu, make the following Regulation.

#### 1 Privileges for Honorary Citizenship

- (1) A person and his or her spouse being conferred with honorary citizenship under the Vanuatu Economic Rehabilitation Program are entitled to the following privileges:
  - (a) a Vanuatu passport; and
  - (b) a child and a resident dependant of the person or his or her spouse are entitled to Vanuatu passport.
- (2) For the purposes of this clause:

"child" means a natural or adopted child of an applicant or of the spouse or a child of the applicant and who has not attained 18 years;

"resident dependant" means:

(a) a natural or adopted son or daughter of an applicant who is of 18 to 25 years of age and who is resident with and dependant upon an applicant or a spouse and attending full-time education; or

(b) a parent who is resident with and dependant upon an applicant or a spouse and over the age of 65.

#### 2 Commencement

This Regulation commences on the date on which it is made.

Money Wheel Rules Notice No. 124 of 2015

In exercise of the powers conferred on me by subsection 41(1) of the Casino Control Act [CAP 223], I, the Honourable MAKI STANLEY SIMELUM Minister of Finance and Economic Management, make the following Notice.

#### 1 Gaming Rules

The gaming rules for the Money Wheel are set out in the Schedule.

#### 2 Commencement

This Order commences on the day on which it is made.

#### SCHEDULE

#### MONEY WHEEL RULES

#### 1 Interpretation

In this rule, unless the contrary intention appears:

colour chips means chips without any denomination markings;

dealer means a person responsible for the operation of the game;

**supervisor** means a person responsible for the immediate supervision of the operation of the game;

value chips means chips marked with denominations of value;

void means invalid with no result;

wagering period means the period determined by the casino during which a player is permitted to place, move or remove bets. The period commences when the dealer starts a new game and finishes when the dealer calls "no more bets".

#### 2 Table layout and equipment

- (1) The game of Money Wheel must be played at a table having on one side places for the players and on the opposite side a place for the dealer, with a circular wheel of not less than 1.5 metres in diameter.
- (2) The rim of the wheel must be divided, by means of pegs, into 52 equally spaced sections which must be marked in the same order shown in Diagram A and has the following:
  - (a) 24 sections exhibiting one particular symbol or number;
  - (b) 12 sections exhibiting a second particular symbol or number;
  - (c) 8 sections exhibiting a third particular symbol or number;
  - (d) 4 sections exhibiting a forth particular symbol or number;
  - (e) 2 sections exhibiting a fifth particular symbol or number;
  - (f) 1 section exhibiting a sixth particular symbol or number;
  - (g) 1 section exhibiting a seventh particular symbol or number.

- (3) The layout of the table must display the name and logo of the casino and must have areas designated for the placement of wagers.
- (4) The equipment must also be used an indicator which stops the wheel and indicates the winning section.
- (5) The table must have a drop box attached to it.

#### 3 Wagers

- (1) An acceptance wager by a player must be a wager on a particular symbol or number, which must:
  - (a) win if the indicator comes to rest in a section of the wheel depicting that particular symbol or number; and
  - (b) lose if the indicator comes to rest in a section of the wheel depicting any other symbol or number.
- (2) All wagers must be made by placing value chips or colour chips on the appropriate wagering areas of the layout.
- (3) Colour chips issued at a Money Wheel table must only be used for gaming at that table and must not be used for gaming at any other table in the casino.
- (4) Colour chips must only be presented for redemption at the table from which they were issued and must not be redeemed or exchanged at any other location in the casino unless the table is closed at the time of the redemption request.
- (5) Immediately before the wheel is spun the dealer must call "no more bets". A wager cannot be withdrawn, changed or placed once the wheel has started spinning, nor wagers must be placed or removed until winning wagers from the previous result have been paid.
- (6) Players are responsible for the positioning of their wagers on the layout, whether or not they are assisted by the dealer. Players must ensure that any instructions given to the dealer regarding the placement of the wagers are correctly carried out.
- (7) Wagers must be settled strictly in accordance with the position of chips on the layout when the indicator comes to rest in a section of the wheel. A casino supervisor or manager may use their discretion to make a decision regarding the position of the chip on the layout.

#### 4 Minimum and Maximum Wagers

- (1) The minimum and maximum wagers permitted by a player must be shown on a sign at the table.
- (2) A wager found to be below the stated minimum, after "no more bets" has been called, must be valid.
- (3) A wager found to be above the stated maximum must be paid or collected to the maximum. In the event that a player has been found to have wagered above the stated maximum on any previous spin(s), the wagers and results of the previous spin(s) must stand and no refunds given.
- (4) Players are responsible for ensuring that their wagers comply with the limits stated on the sign on the table.

#### 5 Rotation of the Wheel

- (1) The wheel must be spun by either a dealer or casino supervisor and the direction of the wheel may be alternated. The wheel must complete at least three full revolutions, measured from the moment the dealer or casino supervisor removes their hand from the wheel for the final time to the time that the indicator comes to rest in a section of the wheel, to constitute a valid spin.
- (2) Upon the indicator coming to rest in a section of the wheel, the dealer or casino supervisor, must announce the winning symbol or number and then the dealer must first collect all losing wagers and then pay all winning wagers.
- (3) No other person other than the dealer or casino supervisor may touch the wheel at any time during a live game.

#### 6 Settlement Odds

Winning wagers at the game of Big Wheel shall be paid at the odds listed below:

Wager	Odds
24 sections referred to in rule 2.2.1	1 to 1
12 sections referred to in rule 2.2.2	3 to 1
8 sections referred to in rule 2.2.3	5 to 1
4 sections referred to in rule 2.2.4	10 to1

2 sections referred to in rule 2.2.5	20 to1
1 section referred to in rule 2.2.6	45 to1
1 section referred to in rule 2.2.7	45 to 1

#### 7 Irregularities

- (1) If a dealer or casino supervisor believes that the wheel will not complete three full revolutions, the dealer or casino supervisor must announce "no spin".
- (2) If the indicator stops on the peg between two sections, all wagers must be void on that spin and the dealer or the casino supervisor must announce "no spin".
- (3) If there is a physical interference or a mechanical malfunction with the spin of the wheel, the dealer or the casino supervisor must announce "no spin".
- (4) If the dealer or the casino supervisor announces "no spin", then all wagers must be void on that spin.
- (5) Once the dealer or casino supervisor has announced "no spin", it must be an invalid spin regardless of whether or not the indicator comes to rest in one of the sections of the wheel.
