PURSUANT to Section 29 of the General Licensing Authority Act 1989, the Queen's Representative, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations:

REGULATIONS

1. Title - (1) These regulations shall be cited as the Tourist Accommodation Licensing Fees Regulations 1990.

2. <u>Interpretation</u> -In these regulations, unless the context otherwise requires ...

"Act" means the General Licensing Authority Act 1989.

"Authority" means the General Licensing Authority established by the General Licensing Authority Act 1989.

Application of regulations - These regulations shall з. apply to every premises which is required to have an accommodation licence.

4. <u>Application fees</u> - The fees prescribed according to the scales set out in the First Schedule to these regulations shall be payable to the Authority when an application is made for an accommodation licence.

5. <u>Approval fees</u> - The fees prescribed according to the scales set out in the Second Schedule to these regulations shall be payable to the Authority upon approval by the Authority of an accommodation licence.

6. <u>Annual licence renewal fees</u> - The fees payable prescribed according to the scales set out in the Third Schedule to these regulations shall be payable to the Authority annually by 1 July each year for the following years accommodation licence.

7. Extension fees - (1) The fees prescribed according to the scales set out in the Fourth Schedule to these regulations shall be payable to the Authority when an application is made for an extension of existing accommodation premises.

(2) The fees payable prescribed according to the scales set out in the Fifth Schedule to these regulations shall be payable to the Authority upon approval given by the Authority for an extension to existing accommodation premises.

8. Fees for 1990/1991 - Notwithstanding anything to the contrary contained herein the fees prescribed according to the scales set out in the Sixth Schedule to these regulations shall be payable to the Authority for an application and approval of an application made in the 1990/91 year and for the annual licence renewal fee for the 1990/91 year.
