THIS IS THE LAST WILL AND TESTAMENT of me, ALVIN JAMES BLUM
of Honiara in the British Solomon Islands Protectorate.

1. I hereby revoke all former Wills and Testamentary dispositions heretofore made by me and I declare this to be my last Will.

2. In the event of my wife, GERTRUDE BLUM being proved to have survived me for a period of thirty (30) days THEN I GIVE, DEVISE and BEQUEATH unto the said GERTRUDE BLUM the whole of my Estate, both real and personal of whatsoever nature and kind and wheresoever situated, for her own sole use and benefit absolutely and I APPOINT her to be the sole Executor of this my Will.

3. In the event of my wife, the said GERTRUDE BLUM not being proved to have survived me for the period of thirty (30) days as aforesaid then I APPOINT JAMES FRANCIS CURTIN of Honiara in the said Protectorate, Accountant, to be the sole Executor and Trustee of this my Will (hereinafter called "my Trustee") and I GIVE, DEVISE and BEQUEATH the whole of my Estate, both real and personal of whatsoever nature and kind and wheresoever situated, unto my Trustee UPON TRUST to sell and call in and convert into money all such parts of my Estate as shall not consist of money with full power to postpone such sale, calling in and conversion and to manage my said Estate and to hold the proceeds of the sale, calling in and conversion of my Estate UPON TRUST for

my daughter KEITH-WILMA SUANDERS for her own sole use and benefit absolutely, but I request that my daughter, the said KEITH-WILMA SAUNDERS at her absolute discretion should make such contribution to the Baha'i Faith as she may deem fit.

4. In the event of neither my wife the said GERTRUDE BLUM or my daughter the said KEITH-WILMA SAUNDERS being proved to have survived me for the period of thirty (30) days as aforesaid THEN I APPOINT the said JAMES FRANCIS CURTIN to be the sole Executor of this my Will and I GIVE, DEVISE and BEQUEATH the whole of my Estate both real and personal of whatsoever nature and kind and wheresoever situated unto the ~~INTERNATIONAL~~ ^{UNIVERSAL} HOUSE OF JUSTICE OF THE BAHAI'I WORLD FAITH (Post Office Box 155, Haifa, Israel) for its own sole use and benefit.

I wish my daughter the said KEITH-WILMA SAUNDERS to know that although I have given her all my Estate, I wish her to make such arrangements as she may desire with her husband for the carrying on of the businesses included in my Estate and that I would like her to come to Honiara and carry on the businesses if she so wishes.
