AN ACT

TO AMEND THE 1995 APPROPRIATION ACT, 1994 PROVIDING FOR THE ALTERATION OF AMOUNTS OR SUMS OF MONEY APPROPRIATED FOR CERTAIN HEADS OF EXPENDITURES

ENACTED by the Parliament of Fiji—

Short title
