## AN ACT

TO AMEND THE CUSTOMS TARIFF ACT, 1986 (ACT 12 OF 1986) (5/92)

[ 22 December, 1992 ]

ENACTED by the Parliament of Fiji.

#### Short title

1. This Act may be cited as the Customs Tariff (Amendment) (No. 2) Act, 1992.

### Interpretation

2. The Customs Tariff Act, 1986, is in this Act referred to as the Principal Act.

## Schedule 2, repealed

3. Schedule 2 to the Principal Act, is repealed and replaced by the SCHEDULE to this Act.

- (a) the following expressions have the following meanings :-
  - (i) 'Standard Tariff' means the Tariff set out in Part 1 of this Schedule;
  - (ii) 'heading' means any of the headings set out in the second column of the Standard Tariff, identified by four digits in that column;
  - (iii) 'item' means any item in the Standard Tariff identified by eight digits in the first column of that Tariff and amy include any heading or subheading or any subdivision of a heading or a subheading;
  - (iv) 'three or more dash sub-divisions' means any sub-division identified by three or more dashes in the description column.
- (b) the symbol % appearing against any rate of duty means per cent ad valorem, and in all other cases means per cent; and
- (c) the following other abbreviations and symbols have the following meanings :-
