GOVERNMENT OF THE REPUBLIC OF FIJI DECREE NO. 32

CUSTOMS TARIFF (AMENDMENT) (NO. 2) DECREE, 1989

A DECREE TO AMEND THE CUSTOMS TARIFF ACT, 1986

In exercise of the powers vested in me as President and Commander-in-Chief of the Republic of Fiji and acting in accordance with the advice of the Prime Minister and the Cabinet, I hereby make the following Decree—

Short title, etc

- 1.—(1) This Decree may be cited as the Customs Tariff (Amendment) (No. 2) Decree, 1989.
 (2) The Customs Tariff Act, 1986 is in this Decree referred to as the "Principle Act".

Part 1 of Schedule 2 amended

- 2.—(1) Part 1 of Schedule 2 to the Principle Act is amended by—

(a) substituting the following items for Tariff Item No. 3920.00.00:

"39.20 Other plates, sheets, film, foil and strip, of plastics, non-cellular and not reinforced, laminated, supported or similarly combined with other materials:

3920.00.10	---	Low or high density polyethylene (polyethylene)	50%	7.5%	Free	582.210	m ²

(b) substituting the following item for Tariff Item No. 7321.90.10:

(2) Part 1 of Schedule 2 to the Principal Act is further amended as set out in the Schedule to this Decree.

Part 2 of Schedule 2 amended

3. Part 2 of Schedule 2 to the Principal Act is amended by—

(a) substituting the expression "Free" for the expression "5%" in column (3) of Code 109;

(b) substituting the following paragraph for paragraph (a) in column (2) of Code 113:

"(a) Equipment and requisites for games and sports as follows:

(i) Gloves for all sports considered to be a requisite for such (such headings as the Comptroller may approve)

(ii) Boots specially designed for boxing, rugby and soccer, and spiked shoes specially designed for athletics (Chapter 64)

(iii) Protective head gear for boxing, cricket and rugby (Heading No. 65.06)

(iv) Knee and ankle supports (Heading No. 61.17)

(v) Skipping ropes (Heading No. 95.03)

(c) substituting the following paragraph for paragraph (a) of Code 117:

"(a) Compound preparations (known as concentrated extracts) and mixtures with a basis of odoriferous substances, for the manufacture of beverages

Part 3 of Schedule 2 amended

4. Part 3 of Schedule 2 to the Principal Act is amended by—

(a) substituting the expression "\$100.00" for the expression "\$50" in paragraph (a) of column (6) of Code 212;

(b) substituting the following paragraph for paragraph (b) in column (6) of Code 213:

"(b) That the goods shall be exported as a result of retail sale immediately prior to their departure to persons about to leave Fiji by air from an approved airport; or, that the goods shall be deemed to have been imported into the country as a result of retail sale to *bona fide* passengers immediately after final disembarkation in Fiji at an approved airport:"

(c) substituting the following paragraph for paragraph (a) in column (6) of Code 218:

- "(a) (i) That the goods are not for sale; and
(ii) That the goods are accompanied, at the time of final disembarkation by the passenger; or, the goods are purchased immediately after final disembarkation in Fiji by the passenger;"

(d) substituting the expression "\$150.00" for the expression "\$100.00" in paragraph (ix) of column (3) of Code 218.

5. This Decree shall come into effect on the 30th day of November 1989.
