AN ACT

TO AMEND THE CUSTOMS TARIFF ACT 1986 IN RESPECT OF CERTAIN ESSENTIAL BASIC ITEMS

[1st January 2006]

ENACTED by the Parliament of the Fiji Islands—

Short title and commencement

1.—(1) This Act may be cited as the Customs Tariff (Essential Basic Items Amendment) (No.2) Act 2005 and shall come into force on 1st January 2006.

2.—(1) Part 1 of Schedule 2 to the Customs Tariff Act 1986 is amended in the manner specified in the Schedule to this Act.
