CUSIONS TARIFF (AMENDMENT) DECREE, 1777

A DECREE TO AMEND THE CUSTOMS TARTET ACT, 1786

IN exercise of the nowers vested in me as President of the Sovereign Description Republic of Fijl and Commander-in-Chief of the Orend Forces and acting in accordance with the advice of the Prime Minister and the Cabinet, I bereby make the following Decree--

## Short title, etc

- ).--(i) This Decree may be cited as the Customa Tariff (Amendment) Decree, 1992.
- (7) The Customs Tariff Act, 1786 is in this Decree referred to as the "Principal Act".

## Part [ [ (Section 3) to the Principal Act, repealed

7. Section 3 in Part II to the Principal Act is repealed and substituted by the following  $\pm$ 

### "Duties to be collected and paid

- Excent, as otherwise provided by this Act, there shall be raised, levied and collected.
- (a) on imported goods -[i] fiscal duty; and [ii] Value Added tax; and

(b)

on exported grads medicand or manufactured in file export duty, at the rates specified in Schedule 2.7.

## Part II (Section 5) to the Principal Act, repealed

3. Section 5 in Part 11 to the Principal Act is repealed and substituted with the following –  $\,$ 

## " Hode of ascertaining value for purposes

- of ad values duties

  3. The value of goods in respect of which ad valorem duty is payable shall be ascertained--
  - (a) in the case of imported goods in accordance with Part 1 (a) and Part 1 (b) of Schedule 1; and
  - (b) in the case of exported goods in accordance with Part 2 of Schedule 1"

## Part 1 of Schedule 1. repealed

4. Part 1 of Schedule 1, to the Principal Act is repealed and substituted as shown in Schedule 1 to this Decree.

### SCHEDULE 2. repealed

5. Schedule 2 to the Principal Act is repealed and substituted as shown in Schedule 2 to this Decree.

## Liability to pay past tax, etc.

- 6.- The americants effected pursuant to Sections 2, 3, 4 and 5 to this Decree shall not affect the right or limitity of any person that existed prior to the coming into force of this Decree, and in particular,  $\pm$ 
  - (a) any liability to tax, or to any fire or penalty, of any person pursuant to the repealed or amended provision, and the right of any person or the State to any revenue, tax, fee, fire, or penalty pursuant to the repeal or amendment provision, shall not be affected by the repeal or amendment; and
  - (b) all acts and proceedings for the assessment or recovery of any revenue, tax, fire, or penalty assessed or assessable or paid or payable pursuant to the repealed or amended provision, and all proceedings in respect of offences committed or alleged to be committed in respect of the repealed or amended provision, may be instituted or continued as if the provision had not been repealed or amended.
  - (c) all persons, things and circumstances appointed or created by or under the Excise Act or existing or continuing under that Act immediately before the commencement of this Decree shall, under and ambject to this Decree, continue to have the same status, operation and effect as they respectively would have had as if the Excise Act had not been repealed or amended; and

(d) in particular and without affecting the generality of paragraph (a) the repeal or amendment of the Excise Act shall not affect licences, permits, bonds, securities, appointments, orders, rules and regulations issued, executed, given or made under or by virtue of that Act and in force immediately before the commencement of this Decree and those licences, permits, bonds, securities, appointments, orders, rules and regulations shall remain in force as if every such licence, permit, bond, security, appointment, order, rule or regulation were issued, executed, given or made under and by virtue of this Decree until replaced or revoked by a licence, permit, bond, security, appointment, order, rule or regulation made under or by virtue of this Decree.

### Connencement

7.- This Decree shall come into force on the 1st day of July, 1377.
