# Births, Deaths and Marriages Registration (Amendment) (No. 2) Regulations 2021

IN exercise of the powers conferred on me by section 32 of the Births, Deaths and Marriages Registration Act 1975 and with the approval of the Minister responsible for justice, I hereby make these Regulations—

#### Short title and commencement

- 1.—(1) These Regulations may be cited as the Births, Deaths and Marriages Registration (Amendment) (No. 2) Regulations 2021.
  - (2) These Regulations are deemed to have come into force on 6 October 2021.
