COMPANIES ACT 2015

Companies (Amendment) Regulations 2019

IN exercise of the powers conferred on me by section 713 of the Companies Act 2015, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Companies (Amendment) Regulations 2019.
 - (2) These Regulations come into force on the date of publication in the Gazette.
- (3) In these Regulations, the Companies Regulations 2015 is referred to as the "Principal Regulations".

Regulation 2 amended

- 2. Regulation 2 of the Principal Regulations is amended by deleting subregulation (1) and substituting the following—
 - "(1) In these Regulations, unless the context otherwise requires—

"Act" means the Companies Act 2015; and

"lodge" includes to electronically lodge.".

Regulation 3 amended

3. Regulation 3(2)(a) of the Principal Regulations is amended after "prescribed form" by inserting "subject to subregulation (1)".

Regulation 4 amended

- 4. Regulation 4 of the Principal Regulations is amended by—
 - (a) renumbering regulation 4 as regulation 4(1); and
 - (b) after subregulation (1), inserting the following new subregulation—
 - "(2) If the prescribed registration fee is paid after the end of the period during which the prescribed registration fee is required to be paid under the Act, a late payment fee must be paid upon payment of the prescribed registration fee with the Registrar as specified in Schedule 4A.".
