CONSTITUTION OF THE REPUBLIC OF FIJI (Section 92(3))

Ministerial Assignment

To: Ro Filipe Qaraniqio Tuisawau
Minister for Public Works, Meteorological Services and Transport

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Minister for Public Works and Meteorological Services, and Transport with effect from 24 December 2022, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 12 of 2023;
