(DECREE NO. 2)

MINISTERIAL ASSIGNMENT

To: Mr Timoci Lesi Natuva
Minister for Works, Transport and Public Utilities

WHEREAS His Excellency Josefa Iloilovatu Uluivuda, in exercise of the powers vested in him as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), and on the advice of the Prime Minister had appointed you as Minister for Works, Transport and Public Utilities, with effect from the 11th day of April 2009 and assigned to you the responsibility for the conduct of Government business and departments and the written laws specified in Legal Notice No. 9 of 2009 dated the 12th of April 2009;

AND WHEREAS, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I revoked with effect from the 1st day of January, 2010, all assignments of responsibilities under Legal Notice No. 9 of 2009 and with effect from the same day assigned to you as the Minister for Works, Transport and Public Utilities the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 61 of 2010;

AND WHEREAS, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I revoked with effect from the 8th day of February, 2011, all assignments of responsibilities under Legal Notice No. 61 of 2010, and with effect from the same day assigned to you as the Minister for Works, Transport and Public Utilities the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 22 of 2011;

AND WHEREAS, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I revoked with effect from the 5th day of January, 2012, all assignments of responsibilities under Legal Notice No. 22 of 2011, and with effect from the same day assigned to you as the Minister for Works, Transport and Public Utilities the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 22 of 2012;

NOW THEREFORE, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji (Amendment) Decree 2009 (Decree No. 28), I hereby revoke with effect from the 12th day of August, 2013, all assignments of responsibilities conferred upon you under Legal Notice No. 22 of 2012, and with effect from the same day assign to you in your current capacity as the Minister for Works, Transport and Public Utilities the responsibility for the conduct of the following Government business and departments and for the following written laws (subject to the provisions of any other laws)—
