## Ministerial Assignment

IN exercise of the powers vested in me by the Office of the Vice-President and Succession Decree 2009 (Decree No. 8) and by the Executive Authority of Fiji Decree 2009 (Decree No. 2), and on the advice of the Prime Minister, I hereby appoint you as Minister for Foreign Affairs, International Cooperation and Civil Aviation with effect from the 3rd day of August 2009;

AND in further exercise of those powers, I hereby confer upon you as Minister for Foreign Affairs, International Cooperation and Civil Aviation with effect from that same date responsibility for the conduct of the following Government business and departments and for the following written laws (subject to the provisions of any other laws) —
