ESSENTIAL NATIONAL INDUSTRIES (EMPLOYMENT) DECREE 2011 (DECREE No. 35 OF 2011)

Essential National Industries & Designated Corporations (Amendment) (No. 2) Regulations 2013

In exercise of the powers vested in me by section 31 of the Essential National Industries (Employment) Decree 2011 and following consultation with the Minister responsible for Industry and Trade, I hereby make these Regulations—

Short title and commencement

1. These Regulations may be cited as the Essential National Industries & Designated Corporations (Amendment) (No. 2) Regulations 2013 and shall come into force on the date of its publication in the *Gazette*.

 - "(i) Fiji Hardwood Corporation Limited";

- (e) by inserting in item 7, the following new designated corporation—
 - "(i) National Fire Authority";
- (f) by inserting in item 8, the following new designated corporations—
 - "(i) Suva City Council
 - (ii) Lautoka City Council
 - (iii) Nausori Town Council
 - (iv) Nasinu Town Council
 - (v) Lami Town Council
 - (vi) Sigatoka Town Council.
 - (vii) Nadi Town Council
 - (viii) Ba Town Council
 - (ix) Tayua Town Council
 - (x) Rakiraki Town Council
 - (xi) Levuka Town Council
 - (xii) Labasa Town Council
 - (xiii) Savusavu Town Council".
