**Town of Rakiraki Order 2010**

IN exercise of the powers conferred upon me by section 5 of the Local Government Act (Cap. 125), I hereby make the following Order—

*Citation*

1. This Order may be cited as the Town of Rakiraki Order 2010.

*Declaration of the Town of Rakiraki*

2. The area defined in the Schedule to this Order is declared to be a town for the purpose of the Local Government Act and is to be known as the town of Rakiraki with effect from the 1st day of July 2010.

## SCHEDULE

## AREA A: RAKIRAKI, KOROWAQA AND PART OF NARIA.

All the area of land commencing at the western corner of RR 594 on Kings Road, thence along the western and northern boundary of RR 594 up to Ra Street; thence north easterly for approximately 15 metres along the boundary of RR 755; thence along Vutoni Street up to the south western corner of RR 467; thence along the western boundaries of Lot 13 and Lot 6, Section 7, RR 1050; thence along the western boundaries of Lots 13 and Lot 6 Section 7 RR 1050 and along Rakiraki Street to its intersection with Vaileka Street; thence along the eastern boundaries of Lots 12 and 6 Section 1 RR 545 and along Kings Road to the south eastern corner of RR 545 and along the nine (9) metre access road; thence across the access road and along the western and northern boundaries of DP 1758 and along the northern boundaries of Lots 4 and 5 DP 1649; thence along the eastern boundaries of Lot 5 and Lot 1 DP 1649 up to the access road and along the access road to the north western corner of Lot 1 DP 7849; thence in a north easterly direction along the boundaries of Lot 1, DP 7849 and Lots 1 and 2, DP 9947; thence across the six (6) metres access road and along the northern boundaries of Lot 1 DP 7849, Lot 1 and Lot 2 DP 9947; thence across the 6metre wide access road and continues along the northern boundaries of Lot 1 and Lot 2 SO 1031; thence along the eastern boundary of Lot 1 SO 1031 up to the Kings Road and across Kings Road to the northern western corner of Lot 3 DP 3835; thence along its western boundary for an approximate distance of 95 metres; thence a straight line parallel to Kings Road for an approximate distance of 300metres on the eastern boundary of Lot 3 DP 6503 and along the eastern boundary of Lot 3 DP 6508; thence across the 6 metre wide drain to the eastern corner of DP 1080 and along the southern boundary of DP 1080 to its south eastern corner; thence in a southerly direction of approximately 100metres along the eastern boundary of RR 911; thence along the southern and south western boundaries of RR 911; thence along the western boundary of SO 2754 for an approximate distance of 253 metres; thence in a south westerly direction along the southern boundaries of Lot 1, SO 5417 and Lot 1 SO 757; thence along the western boundaries of Lot 1 SO 757, the southern boundary of Lot 1 RR 1298 and along the western boundaries of Lot 9 RR 1297; thence part of the eastern boundary of Lot 10, the eastern, southern and western boundaries of Lot 11, RR 1297; thence the western boundary of Lot 10 RR 1297 to its south western corner; thence the eastern boundaries of Lots 10 & 11 DP 5974; thence in a westerly direction along the southern boundaries of Lot 2 DP 4647 to the south eastern corner of Lot 5 DP 9126; thence along the south and western boundaries of DP 9126; thence along the western and north eastern boundary of Lot 1 DP 2816, thence across Rakiraki Access Road to the north western corner of Lot 1 DP 2206; thence continue in a north easterly direction along the north western boundaries of Lot 1 DP 2206 & Lot 1 DP 4647; thence along the northern boundary of DP 3500 up to the western corner of Lot 35, DP 3500; thence along the northern boundary of Lot

33 to Vaileka Street; thence along Vaileka Street to the south eastern corner of Lot 6 Sec 1 RR 545; thence along Kings Road to the western corner of RR 594 being the point of commencement.

**AREA B: NADOVI AND WAIRUKU.**

All the area of land commencing at north eastern corner of RR 616 thence in a westerly direction along the tramline for an approx distance of 80 metres; thence along the eastern, southern and western boundaries of the parcel of native land; thence along the tramline for a distance of approximately 520 metres; thence an approximate distance of 110 metres to the southern bank of the creek; thence on a westerly & southerly direction along the creek to its intersection with Kings Road; thence across Kings Road to the north western corner of Lot 4 DP 7597 and in a southerly direction along the creek to the southern corner of Lot 4, DP 7597; thence along the southern and eastern boundary of Lot 4 DP 7597; thence along the southern boundary of Lot 5 DP 7597 to its south eastern corner; thence along the south western and south eastern boundaries of Lot 8 DP 8991 to its south eastern corner; thence in a southerly direction along the south western and south eastern boundaries of Lot 6 DP 7599; thence in a southerly direction along the south western & southern boundary of RR 28 thence across Vatukacevaceva Road; thence along Vatukacevaceva Road for a distance of 20m; thence along the southern, eastern and northern boundaries of Lot 1, SO 929; thence along Vatukacevaceva Road to its junction with Korotale Valley Road; thence across the road and along the 5.3metre wide road for a distance of approximately 58 metres to the north western corner of Lot 4 RR 1112; thence along the 6 metre wide access road; thence along the south western and south eastern boundaries of Lot 2 RR 1112 up to the south eastern corner of RR 579; thence along the eastern, north eastern and north western boundaries of RR 579 for a distance of approx 112 metres; thence along the eastern and northern boundaries of RR 616 to the north western corner of RR 616; thence across the tramline and along the southern boundary of Lot 1, SO 3261 to the creek; thence in a north easterly direction along the northern boundary of Lot 1 SO 3261; thence across and along the access road and along the southern boundary of Lot 2, SO 3262 at its intersection point with Kings Road; thence across Kings Road and along the eastern boundary of Lot 2, SO 3261; thence across the tramline to the north eastern corner of RR 616 being the commencement point.

**AREA C: VAILEKA AND VATUMAMI.**

All the area of land commencing at the western corner of Lot 1 SO 5391 at Korotale Valley Road thence along the western and northern boundaries of Lot 1 SO 5391 up to the south eastern corner of RR 71; thence along the eastern boundary of RR 885 for an approximate distance of 20 metres along RR 71 and across the Access Road in an easterly direction along the northern boundary of Lot 1 RR 1211 to the western bank of Wailevu Creek; thence across Wailevu Creek and along the north-eastern boundary of part of Lot 1 SO 5212; thence in an easterly direction along the drain parallel to the tramline for an approximate distance of 118 metres; thence along all the boundaries of Lots 8, 9, 10 DP 2787 to its intersection with the tramline; thence across the tramline and Waimari Road and along the north eastern boundary of Lot 5 DP 2787; thence in a southerly direction along the eastern boundaries of SO 4709

to its south eastern corner; thence along the northern boundary of SO 4955 and in a south easterly direction along the eastern boundaries of SO 4595, SO 4546 and SO 4532 up to the western corner of Lot 17 RR 1136; thence along the western and northern boundaries of Lot 17, RR 1136 and along the northern boundaries of Lots 3 -5, SO 2294 and along the boundaries of SO 219 and Lot 3 SO 2294 to its south western corner; thence in an easterly direction for an approximate distance of 180 metres; thence in a northerly direction along the western boundary of Lot 9 RR 1136 to the western bank of Drauniavutia Creek and in a southerly direction along Drauniavutia Creek; thence along the southern boundary of Lot 9 RR 1136 for an approximate distance of 40 metres; thence along the eastern boundary of RR 735; thence in a westerly direction along Drauniavutia Creek to the south eastern corner of RR 734; thence along the southern boundaries of RR 734 and Lot 1 SO 1322; thence across the Korotale Valley Road in a south westerly direction along the boundaries of Lot 1 SO 2425 and Lot 5 RR 896 to the southern corner of Lot 5 RR 896; thence along the western boundary of Lot 5 RR 896 the southern and western boundaries of Lots 1 & 3 SO 5514 and parts of Lots 4 & 5 RR 896, thence in a north westerly direction along the southern boundaries of Lot 2, SO 1318; thence a straight line with an approximate distance of 352 metres; thence along the southern boundary of SO 1286 to the western boundary of the tramline; thence in a northerly direction along the tramline and the eastern boundary of Lot 6, SO 1286 and along the western and northern boundaries of Lot 1 RR 1131; thence in a northerly direction along the tramline for an approximate distance of 56 metres and in a westerly direction across Wailevu Creek and along the southern boundaries of RR 371, Lots 20, RR 880 and Lot 1 SO 1381; thence in a westerly direction for approximately 40 metres along the boundaries of Lots 10 & 12, SO 1087; thence along the northern and eastern boundaries of Lot 1 R 540; thence along the eastern boundaries of Lot 1 RR 601, Lot 1 RR 123 & Lot 1 RR 402; thence along the southern boundary of Lot 1 RR 402 and continues in a north westerly direction for an approximate distance of 60 metres; thence in a north easterly direction for approximately 345 metres to Korotale Valley Road; thence in a north westerly direction along Korotale Valley Road for an approximate distance of 126 metres; thence across Korotale Valley Road to its junction with Vatukaceveva Road, thence across the road to a point along the RR 1112; thence along Korotale Valley Road to the western corner of Lot 1, SO 5391 being the point of commencement.

#### AREA D: COLASI AND PENANG.

All the area of land commencing at the junction of Rakiraki Access Road and along Tuvavatu Road to its junction with the Access Road, thence in a north easterly direction along the access road to the south eastern corner of Lot 1, RR 1154; thence along the eastern boundary of Lot 1, RR 1154 and the southern boundary of Lot 11, RR 1154; thence in a north westerly direction of an approximate distance of 88 metres to the south western corner of Lot 15, RR 1154; thence along the western and northern boundaries of Lot 15 & Lot 14 of RR 1154 to the south western corner of Lot 1, SO 3074; thence along the boundaries of Lot 1 SO 3074 to its north eastern corner, thence in an easterly direction for an approximate distance of 236 metres; along the boundary of Lot 1 SO 1608, thence in a southerly direction up to the eastern boundary of Lot 7 RR 1280 and

along the south eastern boundaries of RR 1280; thence in a south easterly direction along the eastern boundaries of Lots 1 & 2 SO 1192 and Lot 1 SO 870; thence in a southerly direction along the boundary of Lot 1 SO 870 and along the access road running along the southern boundary of RR 1147; thence along the western, northern and eastern boundary of Lot 9, RR 1147; thence along the eastern boundaries of Lot 3, RR 1147, Lot 2, SO 1840 and Lot 11 RR 1147; thence across the 6m wide drain and along the southern bank of the drain for an approximate distance of 52 metres and along the eastern boundary of Lot 2 RR 1278; thence a straight line in a southerly direction for an approximate distance of 60 metres and along the access road along the eastern and south eastern boundary of RR 1278; thence the eastern boundary of Lot 13 RR 1174, the northern boundaries of Lots 2, SO 3960 & Lot 12 RR 1147, the north eastern and eastern boundaries of Lot 12 RR 1147; thence along the eastern boundary of Lot 2, SO 3960 up to Tuvavatu Road and along Tuvavatu Road to the north western corner of Lot 8 RR 1147; thence along the northern boundaries of Lot 8, RR 1147 and Lot 2, SO 4459 and the eastern southern and western boundaries of Lot 2, SO 4159; thence along the access handle of Lot 2 SO 4159 and along Tuvavatu Road; thence the eastern boundaries up to Tuvavatu Road and along the southern and western boundaries of Lot 23, DP 2787 to the south eastern corner of Lot 1 SO 3833; thence the southern, western and northern boundaries of Lot 1 SO 3833, thence along Tuvavatu Road to the south eastern corner of Lot 1 RR 1145 and along the southern and western boundary of Lot 1 RR 1145; thence across Tuvavatu Road to its junction with Rakiraki Access Road and along the road to the tramline and along the tramline to the northern bank of Drauniavutia Creek; thence in a westerly direction for a distance of approximately 50 metres along Tuvavatu Road; thence along the northern bank of Drauniavutia Creek up to north western corner of Lot 13, DP 2787; thence in a south westerly direction along Waimari Road up to the north western corner of Lot 1 RR 1136; thence across and along Waimari Road, the southern bank of Drauniavutia Creek to its intersection with the tramline; thence across the Drauniavutia Creek to its northern bank; thence following the northern bank of the creek to the south eastern corner of Lot 22, RR 1154; thence along the north and north western boundaries of Lot 16, DP 2787; thence along Rakiraki Access Road to its junction with Tuvavatu Road being the commencement point.

The above areas are shown edged in red on PP 695 kept at the office of the Director of Lands and Surveyor General, copies of which are also available for viewing at the offices of the Permanent Secretary for Local Government Urban Development Housing and Environment, Commissioner Western Division, Lautoka and the office of the Provincial Administrator, Rakiraki.
