National and Trade Measurement (Amendment) Regulations 2010

In exercise of the powers conferred upon me by section 65 of the National and Trade Measurement Decree 1989, I hereby make these Regulations—

Citation and Commencement

- 1.-(1) These Regulations may be cited as the National and Trade Measurement (Amendment) Regulations 2010.
 - (2) These Regulations shall commence on the 1st day of January 2011.
- (3) The National and Trade Measurement Regulations of 1989 shall be referred to as the "Principal Regulation".
