NATIVE LAND TRUST ACT (CAP. 134)

NATIVE LAND TRUST (LEASES AND LICENCES) (AMENDMENT) REGULATIONS 2006

IN exercise of the powers conferred upon me by section 33 of the Native Land Trust. Act, I make these Regulations—

Short title and commencement

1. These Regulations may be cited as the Native Land Trust (Leases and Licences) (Amendment) Regulations 2006, and come into force on the 15th day of March 2006.
