PUBLIC HEALTH ACT 1935

Public Health (Infectious Diseases) (Infringement Notices) (Amendment) Regulations 2022

IN exercise of the powers conferred on me by sections 82C and 83 of the Public Health Act 1935, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Public Health (Infectious Diseases) (Infringement Notices) (Amendment) Regulations 2022.
 - (2) These Regulations come into force on 10 January 2022.
- (3) In these Regulations, the Public Health (Infectious Diseases) (Infringement Notices) Regulations 2021 is referred to as the "Principal Regulations".

Regulation 7 amended

- 2. Regulation 7 of the Principal Regulations is amended by—
 - (a) after paragraph (a), deleting "; or";
 - (b) in paragraph (b), deleting "," and substituting "; or"; and
 - (c) after paragraph (b), inserting the following new paragraph—
 - "(c) a ship that operates under a coasting-trade licence,".

Regulations 8A and 8B inserted

3. The Principal Regulations are amended after regulation 8 by inserting the following new regulations—

"Screening

8A. Any person who fails to comply with an order in relation to the requirement to screen staff, customers, clients, crew, pilots and masters for temperature, COVID-19 symptoms or COVID-19, commits a fixed penalty offence.

VAX-Check Tool

8B. Any person who fails to comply with an order in relation to the use of the VAX-Check Tool to verify the COVID-19 vaccination status of any vaccine eligible person, commits a fixed penalty offence.".

Regulation 9 amended

4. The Principal Regulations are amended by deleting regulation 9 and substituting the following—

"Contact tracing

- 9. Any person who fails to comply with an order in relation to the requirement—
 - (a) to display the QR Code for careFIJI check-in;
 - (b) that their employees, customers and clients display the careFIJI mobile application or check-in by scanning the QR Code for careFIJI check-in; or
- (c) to register employee, customer and client details for contact tracing, commits a fixed penalty offence.".

Regulations 11A, 11B and 11C inserted

5. The Principal Regulations are amended after regulation 11 by inserting the following new regulations—

"Spectators at contact sports engagement or tournament

11A. Any organiser of an organised contact sports engagement or tournament that fails to comply with an order to ensure that there are no spectators at the contact sports engagement or tournament, commits a fixed penalty offence.

Dancing

11B. Any business that fails to comply with an order to take reasonable steps to ensure that its customers do not dance, commits a fixed penalty offence.

Prohibition of dancing

11C. Any person who fails to comply with an order to not dance commits a fixed penalty offence.".

Regulation 17A amended

6. Regulation 17A of the Principal Regulations is amended after "gathering" by inserting "or adhere to COVID-Safe operations for houses of worship".

Regulation 17B inserted

7. The Principal Regulations are amended after regulation 17A by inserting the following new regulation—

"Display of maximum capacity in businesses and houses of worship

17B. Any business or house of worship that fails to comply with an order to display the maximum capacity of the premises of the business or house of worship, commits a fixed penalty offence.".

Regulation 18 amended

8. Regulation 18 of the Principal Regulations is amended in the heading after "capacity" by inserting "in public service vehicles".

Regulations 18A, 18B and 18C inserted

9. The Principal Regulations are amended after regulation 18 by inserting the following new regulations—

"Boarding public service vehicles

18A. Any person who fails to comply with an order to only board a public service vehicle that has less than 80 percent passenger capacity, commits a fixed penalty offence.

Passenger capacity in ships

18B. Any person who fails to comply with an order to limit passenger capacity in ships commits a fixed penalty offence.

Display of maximum capacity in public service vehicles and ships

18C. Any business that operates a public service vehicle or ship under a coasting-trade licence that fails to comply with an order to display the maximum capacity of the public service vehicle or ship, commits a fixed penalty offence.".

Regulations 23A, 23B and 23C inserted

10. The Principal Regulations are amended after regulation 23 by inserting the following new regulations—

"COVID-19 vaccination

23A. Any high-risk business or business that operates a ship under a coasting-trade licence that fails to comply with an order in relation to the requirement to only permit vaccine eligible persons who have received 2 doses of the COVID-19 vaccine into the premises, commits a fixed penalty offence.

Care Fiji Commitment Certification

23B. Any business that provides accommodation services to visitors that fails to comply with an order to acquire and comply with conditions of Care Fiji Commitment Certification in order to provide its services, commits a fixed penalty offence.

COVID-Safe protocols

23C. Any person who fails to comply with an order in relation to a COVID-Safe protocol commits a fixed penalty offence.".

Regulation 24 amended

- 11. Regulation 24(1) of the Principal Regulations is amended by—
 - (a) deleting "commits" and substituting "is alleged to have committed"; and
 - (b) after "the infringement notice", inserting "within 7 days from the date of commission of the alleged offence".

Regulation 25 amended

12. Regulation 25 of the Principal Regulations is amended by deleting "90" and substituting "21".

Regulation 28 amended

13. Regulation 28 of the Principal Regulations is amended by deleting "12 months" and substituting "28 days".

Regulation 29 amended

- 14. Regulation 29 of the Principal Regulations is amended by—
 - (a) in the heading, deleting "third" and substituting "second";
 - (b) after "necessary" wherever it appears, inserting "using the form set out in Schedule 3";
 - (c) in subregulation (1)—
 - (i) deleting "3" and substituting "2";
 - (ii) deleting "8, 9, 13, 14, 15, 16, 17, 19 or 20" and substituting "8, 8A, 8B, 9, 11B, 14, 15, 16, 17, 17A, 17B, 20, 23A, 23B or 23C (except in relation to land transport services and shipping services/ operations)";
 - (iii) after "business", inserting "or house of worship as applicable"; and
 - (iv) deleting "third" and substituting "second"; and
 - (d) in subregulation (2)—
 - (i) deleting "8, 9, 13, 14, 15, 16, 17, 19 or 20" and substituting "8, 8A, 8B, 9, 11B, 14, 15, 16, 17, 17A, 17B, 20, 23A, 23B or 23C (except in relation to land transport services and shipping services/ operations)"; and
 - (ii) deleting "third" and substituting "second".
