TOBACCO CONTROL ACT 2010

Tobacco Control (Amendment) Regulations 2023

In exercise of the powers conferred on me by section 40 of the Tobacco Control Act 2010, I hereby make these Regulations—

Short title and commencement

- 1.-(1) These Regulations may be cited as the Tobacco Control (Amendment) Regulations 2023.
 - (2) These Regulations are deemed to have come into force on 27 January 2023.
- (3) In these Regulations, the Tobacco Control Regulations 2012 is referred to as the "Principal Regulations".

Regulation 5 amended

- 2. Regulation 5 of the Principal Regulations is amended by—
 - (a) in subregulation (1), deleting "each year";
 - (b) in subregulation 2(e), deleting "of the Regulations"; and
 - (c) deleting subregulation (5).

Regulation 7 amended
