CONGRESSIONAL BILL NO. 7-59, C.D.1

## AN ACT

To further amend title 50 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-54 and 5-105, by further amending section 104, as amended by Public Law No. 5-105, to require noncitizens to leave the jurisdiction of the Federated States of Micronesia and return to his country of origin in order to change immigration status, without exception, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 104 of title 50 of the Code of the Federated
- 2 States of Micronesia, as amended by Public Law No. 5-105, is hereby
- 3 further amended to read as follows:
- 4 "Section 104. Entry permits Duration; Habitual
- 5 residence; Change of status.

- (1) Unless otherwise specified, all entry permits are limited to one year maximum period with provision for renewal.
  - (2) A noncitizen who remains in the Federated States of Micronesia as a visitor under section 103(1) for 1 year or more shall be classified as a habitual resident. A habitual resident may be present in the Federated States of Micronesia only for 30 day visits as permitted by section 103(1) of this chapter or for a longer period of time as permitted by section 103(2), (3), (4), (5), (6), (7), (8), (9), (10), (11) or (12) of this chapter.
  - (3) The immigration status of any noncitizen entering or residing in the Federated States of Micronesia may not be changed during his stay in the Federated States of Micronesia except upon written authorization by the President or his designee. For the noncitizen to change status, he shall be required to leave the jurisdiction of
