PRESIDENTIAL COMM. NO. 7-/73

AN ACT

To amend Public Law No. 7-35, Chuuk State public projects, by amending sections 1 and 8, for the purpose of modifying the use of certain funds previously appropriated therein, for the purpose of modifying the allottees of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

	BE IT EMACIED BY THE CONGRESS OF THE PERMITED STATES OF MICHOLOGISM.
1	Section 1. Section 1 of Public Law No. 7-35 is hereby amended
2	to read as follows:
3	"Section 1. Statewide public projects. The sum of
4	\$400,000, or so much thereof as may be necessary, is hereby
5	appropriated from the General Fund of the Federated States
6	of Micronesia for the fiscal year ending September 30,
7	1992, for the purpose of funding statewide public projects
8	in the State of Chuuk. The sum appropriated by this
9	section shall be apportioned as follows:

11	"Section 8. All funds appropriated by this act shall be
12	allotted, managed, administered, and accounted for in
13	accordance with applicable law, including, but not limited
14	to, the Financial Management Act of 1979. The allottee of
15	the funds appropriated under section 1 of this act shall be
16	the Governor of Chuuk State; the allottee of the funds
L7	appropriated under subsections (1), (2), (3), (5), (6),
18	(7), (8), (9), (10), (11) and (12) of section 2 of this act
L9	shall be the Mayor of Weno Municipality; the allottee of
20	the funds appropriated under subsection (4) of section 2 of
21	this act shall be the Mayor of Fono Municipality; the
22	allottee of the funds appropriated under section 4 of this
23	act shall be the President of the Federated States of
24	Micronesia; the allottee of the funds appropriated under
25	sections 5 and 6 shall be the local development authorities

1	of the areas for which the funds are designated; the
2	allottee of the funds appropriated under sections 3, 7(1)
3	and 7(2) of this act shall be the Southern Namoneas
4	Development Authority. The allottee of the funds
5	appropriated under section 7(3) of this act shall be the
6	School Board of the Saramen Chuuk Academy. The allottees
7	shall be responsible for ensuring that these funds, or so
8	much thereof as may be necessary, are used solely for the
9	purposes specified in this act, and that no obligations are
10	incurred in excess of the sums appropriated. The authority
11	of the allottees to obligate funds appropriated by this act
12	shall not lapse."
13	Section 3. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
