## AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99, 5-126, 6-47 and 6-78, to change the use of certain funds previously appropriated for Chuuk State public projects, and by further amending section 8, as amended by Public Laws Nos. 5-99 and 7-2, to change the allottee of certain funds previously appropriated for Chuuk State public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 6 of Public Law No. 5-89, as amended by Public 2 Laws Nos. 5-99, 5-126, 6-47 and 6-78, is hereby further amended to read as follows: 3 "Section 6. Halls, Western Islands and Namonwitto public 4 projects. The sum of \$200,000, or so much thereof as may be 5 6 necessary, is hereby appropriated from the General Fund of 7 the Federated States of Micronesia for the fiscal year 8 ending September 30, 1989, for the purpose of funding 9 certain public projects in the Halls, Western Islands and Namonwitto, Truk State.
