Public Law No. 7 - 6 2

AN ACT

To further amend section 2 of Public Law No. 4-17, as amended by Public Laws Nos. 4-47 and 4-60, for the purpose of reapportioning funds for Kosrae State public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-17, as amended by
2 Public Laws Nos. 4-47 and 4-60, is hereby further amended to read as
