PRESIDENTIAL COMM. NO. 7-267
FSM CONGRESS

To further amend Public Law No. 6-74, as amended by Public Law No. 6-101, Pohnpei State public projects, by amending section 2 to modify the use of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 6-74 is hereby amended to
2 read as follows:

3 "Section 2. Madolenihmw and Kitti public projects. The
4 sum of \$425,000, or so much thereof as may be necessary, is
5 hereby appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending September
7 30, 1990, for the purpose of funding certain public
8 projects in Madolenihmw and Kitti, Pohnpei State. The sum
9 appropriated by this section shall be apportioned as follows:
