Public Law No. 7 - 8 6

AN ACT

To authorize the Government of the Federated States of Micronesia to indemnify and hold harmless the United States of America against financial liability not to exceed the sum of \$100,000, arising from the negligent or wrongful acts or omissions of the participants from the Federated States of Micronesia in the pharmacy intern training program established by the Memorandum of Understanding to be entered into between the U.S. Naval Hospital (Guam) and the FSM National Government, to authorize the appropriation of the sum of \$100,000 for the fiscal year ending September 30, 1993 for the payment of such indemnity if such financial liability arises, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. The Government of the Federated States of Micronesia
- 2 is hereby authorized to indemnify and hold harmless the United States
- 3 of America against any and all liability and expenses not to exceed
- 4 the sum of \$100,000, that may be imposed by law against the United
- 5 States as a result of the negligent or wrongful acts or omissions of
- 6 the Federated States of Micronesia's staff, faculty and trainees
- 7 participating in the pharmacy intern training program established by
- 8 the Memorandum of Understanding to be entered into between the U.S.
- 9 Naval Hospital (Guam) and the FSM National Government, as may be
- 10 amended.
- 11 Section 2. The sum of \$100,000, or so much thereof as may be
- 12 necessary, is hereby authorized to be appropriated from the General
- 13 Fund of the Federated States of Micronesia for the fiscal year ending
- 14 September 30, 1993, for the payment of the indemnity authorized under
- 15 section 1 of this act if the liability covered by such indemnity
- 16 should arise.
- 17 Section 3. All funds authorized to be appropriated by this act
- 18 shall be allotted, managed, administered, and accounted for in
- 19 accordance with applicable law, including, but not limited to, the
- 20 Financial Management Act of 1979. The allottee of the funds
- 21 authorized to be appropriated under this act shall be the President
- 22 of the Federated States of Micronesia or the President's designee,

- 1 who shall be responsible for ensuring that these funds, or so much
- 2 thereof as may be necessary, are used solely for the purpose
- 3 specified in this act, and that no obligations are incurred in excess
- 4 of the sum authorized to be appropriated. The authority of the
- 5 allottee to obligate funds authorized to be appropriated by this act
- 6 shall not lapse.
- 7 Section 4. This act shall become law upon approval by the
- 8 President of the Federated States of Micronesia or upon its becoming
- 9 law without such approval.
