AN ACT

To further amend title 2 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-2, 5-21, 5-50, 6-62 and 7-6, by further amending section 203, as amended by Public Laws Nos. 5-21 and 6-62, to reorganize the executive branch of the Government of the Federated States of Micronesia, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 203 of title 2 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-21 and 6-62, is 2 hereby further amended to read as follows: 3 "Section 203. Departments. 4 (1) There shall be the following departments which 5 shall be responsible for major programs or administrative 6 7 support areas in the Government of the Federated States: (a) Department of Finance; 8 9 (b) Department of External Affairs; (c) Department of Transportation and 10 Communication; 11 12 (d) Department of Resources and Development; 13 (e) Department of Health Services; and 14 Department of Education. (f) The administrative head of each department shall 15 (2)16 be designated as a 'Secretary.' (3) Succession. 17 (a) Any reference to the Office of Information, 18 the Office of Personnel, the Office of Education, the Office 19 of Health Services, the Department of Human Resources, or 20 21 the Department of Transportation shall apply to the 22 appropriate successor entity.

1 (b) Any reference to any official or employee of 2 an entity referred to in subsection (3) (a) of this section 3 shall be construed as applying to the person holding the 4 same or most similar position in the appropriate successor 5 entity."

6 Section 2. For purposes of the amendments made in this act, the 7 current Secretary of the Department of Human Resources may become the 8 Secretary of the Department of Health Services with no renomination 9 for this position necessary.

10 Section 3. This act shall become law upon approval by the 11 President of the Federated States of Micronesia or upon its becoming 12 law without such approval.
