AN ACT

PRESIDENTIAL COMM. NO._______

To borrow the sum of \$6,500,000 from the Asian Development Bank on the public credit; to ratify the Fisheries Development Project Loan Agreement of 1992 between the Government of the Federated States of Micronesia and the Asian Development Bank, and the Technical Assistance Agreement of 1992 for Institutional Strengthening for Marine Resources Management and Conservation between the Government of the Federated States of Micronesia and the Asian Development Bank; to further amend title 55 of the Code of the Federated States of Micronesia, as amended, by adding a new subchapter VII of chapter 6 to establish an Asian Development Bank Loan Fund; to appropriate the sum of \$7,654,949 from the General Fund for the fiscal year ending September 30, 1993 to carry out the purposes of the Fisheries Development Project Loan Agreement of 1992 between the Government of the Federated States of Micronesia and the Asian Development Bank, and the Technical Assistance Agreement of 1992 for Institutional Strengthening for Marine Resources Management and Conservation between the Government of the Federated States of Micronesia and the Asian Development Bank; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Pursuant to the power vested in the Congress of
- 2 the Federated States of Micronesia by article IX, section 3(a) and
- 3 (b) of the Constitution of the Federated States of Micronesia, the
- 4 Congress of the Federated States of Micronesia hereby ratifies the
- 5 Fisheries Development Project Loan Agreement of 1992 between the
- 6 Government of the Federated States of Micronesia and the Asian
- 7 Development Bank, and the Technical Assistance Agreement of 1992 for
- 8 Institutional Strengthening for Marine Resources Management and
- 9 Conservation between the Government of the Federated States of
- 10 Micronesia and the Asian Development Bank, except that the functions,
- 11 obligations, rights and responsibilities of the National Fisheries
- 12 Corporation, pursuant to such agreements, shall be assumed, instead,
- 13 by the President of the Federated States of Micronesia. Such
- 14 agreements, as modified, shall be hereinafter collectively
- 15 referred to as the "ADB Loan Agreement of 1992."
- 16 Section 2. The President of the Federated States of
- 17 Micronesia, or his designee, is hereby authorized to execute, when
- 18 appropriate, on behalf of the Government of the Federated States of
- 19 Micronesia, the final Fisheries Development Project Loan Agreement of
- 20 1992 between the Government of the Federated States of Micronesia and
- 21 the Asian Development Bank, and the Technical Assistance Agreement of
- 22 1992 for Institutional Strengthening for Marine Resources Management

- 16 applicable law, including, but not limited to, the Financial
- 17 Management Act of 1979. The allottee shall be responsible for
- 18 ensuring that these funds, or so much thereof as may be necessary,
- 19 are used solely for the purposes specified in this act, and that no
- 20 obligations are incurred in excess of the sums appropriated. The
- 21 authority of the allottee to obligate funds appropriated by this act
- 22 shall not lapse.
