### AN ACT

To appropriate the sum of \$49,291 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of providing operating funds to the Board of Regents of the College of Micronesia-FSM, and to further amend Public Law No. 7-78, as amended by Public Law No. 7-80, by amending section 10 to alter the funding for the Community College of Micronesia, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$49,291, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September 30,
- 4 1993, for the purpose of providing operating funds for the Board of
- 5 Regents of the College of Micronesia-FSM.
- 6 Section 2. Section 10 of Public Law No. 7-78 is hereby amended
- 7 to read as follows:

## "Section 10. College of Micronesia.

- (1) The sum of \$400,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, to the College of Micronesia to defray costs associated with the instruction of students and the operations and maintenance of the College. Such funds shall be deemed to come from funds available under section 216(a)(3) of the Compact of Free Association.
- (2) The sum of \$400,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, to the College of Micronesia-FSM to defray the costs associated with the instruction of students, operations and maintenance of the College and its

1	Continuing Education Centers in the States, and to assist
2	FSM citizens attending the campuses of the College of
3	Micronesia in the Republics of the Marshall Islands and
4	Palau. Such funds shall be deemed to come from funds
5	available under section 216(a)(3) of the Compact of Free
6	Association. The sum appropriated by this subsection shall
7	be apportioned as follows:
8	(a) Personnel expenses \$195,000
9	(b) Travel 40,000
10	(c) Contractual services, grants,
11	subsidies, and contributions
12	(d) Others 65,000
13	(e) Continuing Education Centers
14	in each of the FSM States 40,000
15	(f) Assistance to FSM citizens
16	attending other COM campuses 25,000"
17	Section 3. All funds appropriated by this act shall be allotted,
18	managed, administered, and accounted for in accordance with applicable
19	law, including, but not limited to, the Financial Management Act of
20	1979. The allottee of the funds appropriated under this act shall be
21	the President of the Federated States of Micronesia or his designee,
22	who shall be responsible for ensuring that these funds, or so much
23	thereof as may be necessary, are used solely for the purpose specified
24	in this act, and that no obligations are incurred in excess of the sum
25	appropriated. The authority of the allottee to obligate funds
