AN ACT

To appropriate the sum of \$3,259,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of constructing and/or improving roads and/or airports in the four States, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$1,300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the 2 Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of constructing and/or improving roads and/or 5 airports in Chuuk State. The funds appropriated under this section 6 are to be expended only if they have first been matched by the State and/or municipal governments of Chuuk State. The sum appropriated 7 under this section shall be apportioned as follows: 9 (1) Faichuk \$300,000 (2) Southern Namoneas 400,000 10 (3) Northern Namoneas 200,000 11 (4) Mortlocks 12 200,000 13 (5) Western, Namonuito and Hall Islands.. Section 2. The sum of \$200,000, or so much thereof as may be 14 necessary, is hereby appropriated from the General Fund of the 15 Federated States of Micronesia for the fiscal year ending September 30,

- Section 3. The sum of \$359,000, or so much thereof as may be 19
- necessary, is hereby appropriated from the General Fund of the 20

9	Section 4. The sum of \$500,000, or so much thereof as may be
10	necessary, is hereby appropriated from the General Fund of the
11	Federated States of Micronesia for the fiscal year ending September 30
12	1993, for the purpose of constructing and/or improving roads and/or
13	airports in Yap State.
14	Section 5. The sum of \$400,000, or so much thereof as may be
15	necessary, is hereby appropriated from the General Fund of the
16	Federated States of Micronesia for the fiscal year ending September
17	30, 1993, for the purpose of constructing and/or improving the
18	Sokehs circumferential road and Iohl Road in Pohnpei State.
19	Section 6. The sum of \$500,000, or so much thereof as may be
20	necessary, is hereby appropriated from the General Fund of the
21	Federated States of Micronesia for the fiscal year ending September
22	30, 1993, for the purpose of constructing and/or improving roads in
23	the Kitti and Madolenihmw Municipalities in Pohnpei State. The sum
24	appropriated under this section shall be apportioned as follows:

(1) Improving and constructing roads in Madolenihmw, funds

4	Section 7. All funds appropriated by this act shall be allotted,
5	managed, administered, and accounted for in accordance with applicable
6	law, including, but not limited to, the Financial Management Act of
7	1979. The allottee of the funds appropriated under section 1 of this ac
8	shall be the President of the Federated States of Micronesia. The
9	allottee of the funds appropriated under subsection (1) of section 3
10	of this act shall be the Pohnpei Port Authority. The allottee of the
11	funds appropriated under subsection (2) of section 3 of this act shall
12	be the Pohnpei Community Action Agency. The allottee of the funds
13	appropriated under subsection (1) of section 6 of this act shall be
14	the Chief Executive Officer of Madolenihmw Municipality, Pohnpei
15	State. The allottee of the funds appropriated under subsection (2)
16	of section 6 of this act shall be the Chief Executive Officer of
17	Kitti Municipality, Pohnpei State. The allottees shall be responsible
18	for ensuring that these funds, or so much thereof as may be necessary,
19	are used solely for the purposes specified in this act, and that no
20	obligations are incurred in excess of the sum appropriated. The
21	authority of the allottees to obligate funds appropriated by this act
22	shall lapse as of September 30, 1994.
