PRESIDENTIAL COMM. NO. 8-139 FSM CONGRESS

To further amend Public Law No. 6-89, as amended by Public Laws Nos. 7-7, 7-48, 7-51 and 7-95, by further amending section 3, as amended by Public Laws Nos. 7-7, 7-48, 7-51 and 7-95, to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 3 of Public Law No. 6-89, as amended by
- Public Laws Nos. 7-7, 7-48, 7-51 and 7-95, is hereby further amended
- to read as follows: 3

4 "Section 3. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in 5 accordance with applicable law, including, but not limited 6 7 to, the Financial Management Act of 1979. The allottee of 8 the funds appropriated under subsection (1) of section 2 9 of this act shall be the Chairman of the KSCIP. The 10 allottee of the funds appropriated under subsection (5) of section 2 of this act shall be the Mayor of Utwe 11 Municipality. The allottee of the funds appropriated under 12 13 subsection (2) of section 2 of this act shall be the Mayor of Lelu Municipality. The allottee of the funds 14 15 appropriated under subsection (3) of section 2 of this act 16 shall be the Mayor of Tafunsak Municipality. The allottee 17 of the funds appropriated under subsection (4) of section 2 18 of this act shall be the Mayor of Malem Municipality. The 19 allottee of the funds appropriated under subsection (6) of 20 section 2 of this act shall be the Chairman of the Kosrae 21 Congressional Delegation. The allottees shall be responsible for ensuring that these funds, or so much 22

2	purposes specified in this act, and that no obligations are
3	incurred in excess of the sum appropriated. The authority

7	President of the Federated States of Micronesia or upon its becoming
8	law without such approval.
