PRESIDENTIAL COMM. NO. 8-140
FSM CONGRESS

To further amend Public Law No. 7-24, as amended, Pohnpei State public projects, by further amending section 2, as amended by Public Laws Nos. 7-63, 7-74, 7-84, 7-108 and 7-132, to modify the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 7-24, as amended by
2 Public Laws Nos. 7-63, 7-74, 7-84, 7-108 and 7-132, is hereby further
3 amended to read as follows:

4 "Section 2. Madolenihmw and Kitti public projects. The
5 sum of \$875,000, or so much thereof as may be necessary, is
6 hereby appropriated from the General Fund of the Federated
7 States of Micronesia for the fiscal year ending September
8 30, 1992, for the purpose of funding public projects in
9 Madolenihmw and Kitti, Pohnpei State. The sum appropriated
10 by this section shall be apportioned as follows:

- 11 (1) Madolenihmw public projects
 - 12 (a) Section 1 water system
 - 13 development project -- funds may be expended
 - 14 for the purpose of matching funds received
 - 15 from other sources..... \$ 50,000
 - 16 (b) Section 2 water system development
 - 17 project -- funds may be expended for the
 - 18 purpose of matching funds received from other
 - 19 sources..... 50,000
 - 20 (c) Section 3 Kitamw water tank project,
 - 21 with remainder to be used to begin construction of
 - 22 Pohndol water system development project..... 50,000


