CONGRESSIONAL BILL NO. 8-150, C.D.1

Public Law No. 8 - 34

AN ACT

To further amend Public Law No. 7-35, Chuuk State public projects, as amended, by further amending section 1, as amended by Public Laws Nos. 7-43 and 7-68, for the purpose of modifying the use of certain funds previously appropriated therein; by further amending section 8, as amended by Public Laws Nos. 7-43 and 8-17, for the purpose of changing the allottee of funds previously appropriated therein; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-35, as amended by
2 Public Laws Nos. 7-43 and 7-68, is hereby further amended to read as
3 follows:

4 "Section 1. Statewide public projects. The sum of \$400,000,
5 or so much thereof as may be necessary, is hereby appropriated
6 from the General Fund of the Federated States of Micronesia
7 for the fiscal year ending September 30, 1992, for the purpose
8 of funding statewide public projects in the State of Chuuk.
9 The sum appropriated by this section shall be apportioned
10 as follows:

- 11 (1) Chuuk medical students allowance -
- 12 Pacific Basin Medical Officers Training
- 13 Program.....\$20,400
- 14 (2) Chuuk Red Cross..... 5,000
- 15 (3) Medical supplies and equipment..... 50,000
- 16 (4) Rural water system - TOCA..... 40,000
- 17 (5) Hall Islands Jr. High School..... 10,000
- 18 (6) Farmers Home Administration - Chuuk office. 7,000
- 19 (7) Mortlocks regional projects
- 20 (a) Oneop ice plant operating
- 21 expenses..... 15,000
- 22 (b) Satawan ice plant operating


15 Section 2. Section 8 of Public Law No. 7-35, as amended by
 16 Public Laws Nos. 7-43 and 8-17, is hereby further amended to read
 17 as follows:

18 "Section 8. All funds appropriated by this act shall be
 19 allotted, managed, administered, and accounted for in
 20 accordance with applicable law, including, but not limited
 21 to, the Financial Management Act of 1979. The allottee of
 22 the funds appropriated under section 1 of this act shall be
 23 the Governor of Chuuk State; the allottee of the funds
 24 appropriated under subsections (1), (2), (3), (5), (6), (7),
 25 (8), (9), (10), (11) and (12) of section 2 of this act shall



1 be the Mayor of Weno Municipality; the allottee of the
 2 funds appropriated under subsection (4) of section 2 of this
 3 act shall be the Mayor of Fono Municipality; the allottee
 4 of the funds appropriated under section 4 of this act shall
 5 be the Faichuk PWP Development Authority; the allottee of the
 6 funds appropriated under sections 5 and 6 shall be the local
 7 development authorities of the areas for which the funds are
 8 designated; and the allottee of the funds appropriated under
 9 sections 3, 7(1) and 7(2) of this act shall be the Southern
 10 Namoneas Development Authority. The allottee of the funds
 11 appropriated under section 7(3) of this act shall be the
 12 School Board of the Saramen Chuuk Academy. The allottees
 13 shall be responsible for ensuring that these funds, or so
 14 much thereof as may be necessary, are used solely for the
 15 purposes specified in this act, and that no obligations are
 16 incurred in excess of the sums appropriated. The authority
 17 of the allottees to obligate funds appropriated by this act
 18 shall not lapse."

19 Section 3. This act shall become law upon approval by the
 20 President of the Federated States of Micronesia or upon its becoming
 21 law without such approval.
