To further amend Public Law No. 4-92, as amended, Kosrae State public projects, by further amending section 2, as amended by Public Laws Nos. 4-108, 7-4, 7-28, 7-46, 7-128 and 8-33, to change the use of funds previously appropriated therein, by further amending section 3, as amended by Public Laws Nos. 4-108 and 8-37, to modify the allottee for certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

22	"Section 3	3. A	ll funds appropriated by this act sha	all be
23	allotted,	mana	ged, administered, and accounted for	in

25	to, the Fi	nanc	ial Management Act of 1979. The allo	ttee of

1	the funds appropriated under subsection (1) of section 2
2	shall be the chairman of the Kosrae State Commission on
3	Improvement Projects. The allottee of the funds
4	appropriated under subsections (2), (3), (4), and (5) of
5	section 2 shall be the Mayors of Utwe, Malem, Lelu and
6	Tafunsak Municipalities, respectively. The allottee of the
7	funds appropriated under subsection (7) of section 2 shall
8	be the chairman of the board of KICA. The allottee of the
9	funds appropriated under subsections (8) and (11) of
10	section 2 shall be the chairman of the Kosrae congressional
11	delegation. The allottee of the funds appropriated under
12	subsections (6), (9), and (10) of section 2 shall be the
13	Governor of the State of Kosrae. The allottees shall be
14	responsible for ensuring that these funds, or so much
15	thereof as may be necessary, are used solely for the
16	purposes specified in this act, and that no obligations are
17	incurred in excess of the sum appropriated. The authority
18	of the allottees to obligate funds appropriated by this act
19	shall remain effective until all funds are fully expended."
