

AN ACT

To further amend Public Law No. 8-19, as amended by Public Law No. 8-72, by further amending section 2, as amended by Public Law No. 8-72, for the purpose of modifying the allocation of funds previously appropriated for Chuuk and Pohnpei States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-19, as amended by


