Public Law No. 8 - 1 5 0

AN ACT

To further amend Public Law No. 7-24, as amended, by further amending section 5, as amended by Public Laws Nos. 7-74, 7-84, 7-105, 8-40 and 8-119, to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 5 of Public Law No. 7-24, as amended by Public Law
2	Nos. 7-74, 7-84, 7-105, 8-40 and 8-119, is hereby further amended to read a
3	follows:
4	"Section 5. All funds appropriated by this act shall be allotted,
5	managed, administered, and accounted for in accordance with
6	applicable law, including, but not limited to, the Financial
7	Management Act of 1979. The allottee of the funds appropriated
8	under subsections (6), (7), (8), (9), (10), (11), (12), (13), (14),
9	(16) and (19) of section 1 of this act and under subsections (1),
10	(2), (3), (4), (5), (6), (7), (8), and (9) of section 3 of this act
11	shall be the President of the Federated States of Micronesia. The
12	allottee of the funds appropriated under subsection (15) of
13	section 1 of this act shall be the President of the Federated State
14	of Micronesia. The allottee of the funds appropriated under
15	subsection (1) of section 2 of this act shall be the
16	Meninkederlapalap of the Municipality of Madolenihmw. The allotte
17	of the funds appropriated under subsection (2) of section 2 of thi
18	act shall be the Lukenmoanlap of the Municipality of Kitti. The
19	allottees of the funds appropriated under section 2 of this act
20	shall submit detailed funds status and project status reports to
21	the Congress of the Federated States of Micronesia at the
22	beginning of each quarter of each fiscal year until the funds



appropriated thereunder are fully expended. The allottee of the
funds appropriated under section 4 of this act shall be the
Governor of Pohnpei State. The allottee of the funds appropriated
under subsection (1) of section 1 of this act shall be the Pohnpei
State PTA. The allottee of the funds appropriated under
subsection (2) of section 1 of this act shall be the Mayor of
Kolonia Town. The allottee of the funds appropriated under
subsections (3), (4), (17) and (18) of section 1 of this act shall be
the Chief Magistrate of Sokehs Municipality. The allottee of the
funds appropriated under subsection (5) of section 1 of this act
shall be the Luhkenkolwof of Sapwuahfik Municipality. The allottee
of the funds appropriated under subsection (11) of section 3 of
this act shall be the Farmers Home Administration. The allottees
shall be responsible for ensuring that these funds, or so much
thereof as may be necessary, are used solely for the purposes
specified in this act, and that no obligations are incurred in excess
of the sum appropriated. The authority of the allottee of the
funds appropriated under subsection (15) of section 1 of this act
to obligate funds shall lapse as of September 30, 1994. The
authority of all other allottees to obligate funds appropriated by
this act shall not lapse."
