## AN ACT

To amend Public Law No. 9-051 by amending section 1 for the purpose of allocating \$90,000 for operations of an independent project management staff to review, supervise and expedite capital improvements to transportation systems and other public projects in Election District No. 2; by amending section 2 to change the lapse date of the funds appropriated under subsection (b) of section 1; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 9-051 is hereby amended to read as follows:

"Section 1. The sum of \$1,800,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of funding capital improvements to transportation systems, public projects and for other purposes in the LeLe areas of Pohnpei, otherwise known as Election District No. 2, and to fund the operations of an independent project management staff to review, supervise and expedite such improvements and projects, to be apportioned as follows:

(1) Capital improvements to transportation s	systems and
public projects\$	1,710,000
(2) Operation, LeLe Project	
Management Staff	90,000"

Section 2. Section 2 of Public Law No. 9-051 is hereby amended to read as follows:

"Section 2. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee; PROVIDED, that no funds shall be obligated or disbursed prior to a consultation amount the allottee, the chief executive officer, or officers, representing the municipality affected by the proposed project or program, and the representative to the national Congress then representing Election District No. 2 of the State of Pohnpei. The allottee shall be responsible for

ensuring that these funds, or so much thereof as may be necessary, are used solely for the propose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to obligate funds appropriated by subsection (a) of section 1 of this act shall lapse as of September 30, 1997. The authority of the allottee to obligate funds appropriated by subsection (b) of section 1 of this act shall not lapse."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
