PUBLIC LAW NO. 9-144

AN ACT

To further amend Public Law No. 9-052, as amended by Public Laws Nos. 9-071, 9-086, 9-094, 9-108 and 9-117, by further amending section 3, as amended by Public Laws Nos. 9-086 and 9-117, and to amend Public Law No. 9-125 by amending section 2, to correct certain errors contained therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 3 of Public Law No. 9-052, as amended by Public Laws Nos. 9-086 and 9-117, is hereby further amended to read as follows:

"Section 3. The sum of \$1,100,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of capital improvements to the transportation system, public projects and for other purposes in Kosrae State. The funds appropriated under this section shall be apportioned as follows:

(1) Road development and related	
activities in Kosrae State	\$ 370,000
(2) Office of the Governor: office	
construction/renovation and landscaping	100,000
(3) Kosrae State Hospital: renovation and	
maintenance/pharmaceuticals	30,000
(4) Department of Public Safety	20,000

(a) Lelu Municipality projects including administrative costs attributable thereto not to exceed

(5) Municipal public projects

fifteen percent of the sum provided in this line item	135,000
(b) Tafunsak/Walung Municipality projects	
including administrative costs attributable thereto	
not to exceed fifteen percent of the sum provided	
in this line item	135,000
(c) Utwe Municipality projects including	
administrative costs attributable thereto not to exceed	
fifteen percent of the sum provided in this line item	110,000
(d) Malem Municipality projects including	
administrative costs attributable thereto not to exceed	
fifteen percent of the sum provided in this line item	120,000
(6) FSM Congressional Delegation Office	
ten year lease or purchase	30,000
(7) Pukusrik River Bridge	43,000
(8) Other Lelu infrastructure projects	7,000"

Section 2. Section 2 of Public Law No. 9-125 is hereby amended to read as follows:

"Section 2. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated herein shall be the President of the Federated States of Micronesia or the President's designee. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum

appropriated. The authority of the allottee to obligate funds appropriated by this act shall lapse as of September 30, 1998."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
