AN ACT

To further amend Public Law No. 8-24, as amended by Public Laws Nos. 8-56, 8-114, 9-003, 9-077 and 9-145, by further amending section 2, as amended by Public Law No. 8-56, for the purpose of modifying funds previously appropriated for Mortlocks, Chuuk State and to exempt funds so modified from the lapse provisions of Public Law No. 9-040, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 8-24, as amended by Public Law No. 8-56, is hereby further amended to read as follows:

"Section 2. The sum appropriated under section 1 of this act shall be apportioned as follows:

Section 2. The authority of the allottee to obligate funds whose use is  
modified by this act shall be exempt from the lapse provisions of Public Law No. 9-040.

Section 3. This act shall become law upon approval by the President of the  
Federated States of Micronesia or upon its becoming law without such approval.
