## AN ACT

To amend 52 TTC 206, as amended by Public Law IC-3 and Public Law 1-34, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. 52 TTC 206, as amended by Public Law IC-3 and Public Law

2 1-34, is hereby further amended to read as follows:

"Section 206. Fees. Fees collected by the Authority pursuant to Section 154 (7) shall be deposited in the General Fund of the Congress of the Federated States of Micronesia, or its successor; PROVIDED, HOWEVER, that in the case of fees collected from a joint fishing venture, and if its application for a fishing permit includes a request for rebate of fees which the Authority accepts pending its decision to rebate the fee, such fees shall be deposited in a separate trust account maintained by the Authority until rebated to the joint fishing venture or paid into the General Fund of the Congress of the Federated States of Micronesia, or its successor, if the rebate request is denied; and PROVIDED FURTHER, that in the case of fees paid in goods or services rather than money, such goods and services shall be distributed, sold or otherwise disposed of by the Congress of the Federated States of Micronesia by Resolution while in session, and by the appropriate Committee of the Congress between sessions."
