CONGRESSIONAL BILL NO. 1-212, CD1,

AN ACT

To authorize the appropriation of not more than \$200,000 from the General Fund of the Federated States of Micronesia for the purpose of providing funds for student loans for post-secondary and graduate levels of training for citizens of the Federated States of Micronesia, to appropriate \$100,000 of the sum authorized, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$200,000, or so much thereof as may be
- 2 necessary, is hereby authorized for appropriation from the General Fund
- 3 of the Federated States of Micronesia for the 1980 1981 school year
- 4 for the purpose of providing funds for student loans for post-secondary
- 5 and graduate levels of training for deserving citizens of the Federated
- 6 States of Micronesia.
- 7 Section 2. The sum of \$100,000 of the total sum authorized for
- 8 appropriation by Section 1 of this act is hereby appropriated from the
- 9 General Fund of the Federated States of Micronesia for the purpose of
- 10 providing funds for student loans for post-secondary and graduate levels
- 11 of training for deserving citizens of the Federated States of Micronesia
- 12 for the 1980 1981 school year.
- 13 Section 3. The sum loaned to a continuing or new undergraduate
- 14 student pursuant to this act shall not exceed the amount of the student's
- 15 Basic Educational Opportunity Grant as determined by the Basic Educational
- 16 Opportunity Grants Payment Schedule of Awards for the school year for
- 17 which the loan is made. The sum loaned to a graduate student pursuant to
- 18 this act shall not exceed \$2,000 for any school year.
- 19 Section 4. The sum appropriated under Section 2 shall be allotted
- 20 to the President or his designee who shall be legally responsible for
- 21 ensuring that these funds are used only for the purposes specified.
- 22 Section 5. The sum appropriated under Section 2 shall be

1	administered and managed in accordance with the provisions of Public
2	Law No. 1-45, the Financial Management Act of 1979 and other law
3	applicable to the administration of the Student Loan Fund. Any portion
4	of the sum appropriated by this act which is not obligated as of
5	September 30, 1981, shall revert to the General Fund of the Federated
6	States of Micronesia.
7	Section 6. This act shall become law upon approval by the President
8	or upon its becoming law without such approval.
