

TWELFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND SPECIAL SESSION, 2002 CONGRESSIONAL BILL NO. 12-91, C.D.1, C.D.2

AN ACT

To further amend Public Law No. 10-143, as amended, by amending section 2 to change the use of Pohnpei Election District No. 1 funds and by amending section 5 to change the allottees of funds for Election District No. 1 in Chuuk State and for Election District No. 1 in Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-143, as amended by
2 Public Laws Nos. 12-5 and 12-22, is hereby further amended to read as
3 follows:

4 "Section 2. The sum of \$600,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1999, for the purpose of meeting the needs of
8 primary and secondary public schools, providing undergraduate
9 and graduate student scholarships, State hospitals and State
10 administered public health programs, and other social and
11 economic development projects and programs in the State of
12 Pohnpei. The funds appropriated by this section for
13 educational, hospital and public health purposes, shall not
14 be disbursed for salaries, travel, training, or vehicles.
15 The funds appropriated under this section shall be
16 apportioned as follows:

17 (1) Election District No. 1

18 (a) Graduate student scholarships for

1	students from Election District No. 1.....	\$ 10,000
2	(b) Agriculture Day promotional	
3	contest in Kolonia.....	10,000
4	(c) Election District No. 1 project	
5	implementation administrative expenses.....	10,000
6	(d) Other educational, hospital and

8	(2) Election District No. 2.....	200,000
9	(3) Election District No. 3.....	200,000"

10 Section 2. Section 5 of Public Law No. 10-143, as amended by
 11 Public Law No. 12-22, is hereby further amended to read follows:

12 "Section 5. Allotment and management of funds and lapse
 13 date.

14 (1) All funds appropriated by this act shall be allotted,
 15 managed, administered, and accounted for in accordance with
 16 applicable law, including, but not limited to, the Financial
 17 Management Act of 1979. The allottee of the funds
 18 appropriated under section 1(1) of this act shall be the Vice
 19 President of the Federated States of Micronesia, or his
 20 designee. The allottee of the funds appropriated under
 21 section 1(2) of this act shall be the Executive Director of
 22 the Northern Namoneas Development Authority or his designee.
 23 The allottee of the funds appropriated under section 1(3) of
 24 this act shall be the Executive Director of the Chuuk State
 25 Commission on Improvement Projects. The allottee of the

1 funds appropriated under section 1(4) of this act shall be
 2 the Mayor of Polle. The allottee of the funds appropriated
 3 under section 1(5) of this act shall be the Northwest Islands
 4 Project Coordinator or his designee. The allottee of the
 5 funds appropriated under section 1(6) of this act shall be
 6 the Secretary of the Department of Health, Education and
 7 Social Affairs of the Federated States of Micronesia, or his
 8 designee. The allottee of the funds appropriated under
 9 section 2(1)(b) of this act shall be the Mayor of Kolonia.
 10 The allottee of the funds appropriated under section 3 of
 11 this act shall be the Governor of the State of Yap or the
 12 Governor's designee. The allottee of the funds appropriated
 13 under section 4 of this act shall be the Governor of the
 14 State of Kosrae or the Governor's designee. The allottee of
 15 all other funds appropriated by this act shall be the
 16 President of the Federated States of Micronesia or the
 17 President's designee. The allottees shall be responsible for
 18 ensuring that these funds, or so much thereof as may be
 19 necessary, are used solely for the purpose specified in this
 20 act, and that no obligations are incurred in excess of the
 21 sum appropriated.

22 (2) The authority of the allottees to obligate funds
 23 appropriated by this act shall not lapse."

24 Section 3. This act shall become law upon approval by the
 25 President of the Federated States of Micronesia or upon its becoming

1 law without such approval.
