

AN ACT

To further amend Public Law No. 9-100, as amended, by amending section 5 to change the allottee for certain funds previously appropriated to Election District No. 1 in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 5 of Public Law No. 9-100, as  
2 amended by Public Laws Nos. 10-20, 10-44, 10-73, 10-116, 10-  
3 117, 12-8 and 12-62, is hereby further amended to read as  
4 follows:

5           "Section 5. Allotment and management of funds and  
6 lapse date.

7           (1) All funds appropriated by this act shall be  
8 allotted, managed, administered, and accounted for  
9 in accordance with applicable law, including, but  
10 not limited to, the Financial Management Act of  
11 1979. The allottee of the funds appropriated under  
12 subsection (1) of section 1 of this act shall be the  
13 Governor of the State of Chuuk. The allottee of the  
14 funds appropriated under subsection (2) (a), (2) (b),  
15 (2) (c) and (2) (d) of section 1 of this act shall be  
16 the Toleisom Authority. The allottees of the funds  
17 appropriated under subsection (2) (e) and (2) (f),  
18 except for funds appropriated under subsection  
19 (2) (e) (iv) and (2) (f) (iv), of section 1 of this act

1 shall be the mayors of the respective  
2 municipalities. The allottee of the funds  
3 appropriated under subsection (2)(e)(iv),  
4 (2)(f)(iv), (2)(g), (2)(h) and (2)(i) of section 1  
5 of this act shall be the mayor of Polle  
6 Municipality. The allottee of the funds  
7 appropriated under subsections (3) and (5) of  
8 section 1 of this act shall be the Chuuk State  
9 Commission on Improvement Projects. The allottee of  
10 the funds appropriated under subsections (4) and (8)  
11 of section 1 of this act shall be the Northern  
12 Namoneas Development Authority. The allottee of the  
13 funds appropriated under subsection (6) of section 1  
14 of this act shall be the Northwest Islands Project  
15 Coordinator. The allottee of the funds appropriated  
16 under subsection (7) of section 1 of this act shall  
17 be the Speaker of the Congress of the Federated  
18 States of Micronesia or the Speaker's designee. The  
19 allottee of the funds appropriated under subsection  
20 (2) of section 2 of this act shall be the Chairman  
21 of the Kosrae Utilities Authority, and the allottee  
22 of the funds appropriated under subsection (9) of  
23 section 2 of this act shall be the Governor of the  
24 State of Kosrae. The allottee of the funds  
25 appropriated under subsection (1)(a)(i) of section 3

1 of this act shall be the Mayor of Kolonia Town. The  
2 allottee of the funds appropriated under subsections  
3 (1)(a)(ii)a), (1)(a)(ii)b), and (1)(a)(ii)c) of  
4 section 3 of this act shall be the Pohnpei  
5 Transportation Authority. The allottee of the funds  
6 appropriated under subsection (1)(a)(ii)d) of  
7 section 3 of this act shall be the Chief Magistrate  
8 of Sokehs Municipality. The allottee of the funds  
9 appropriated under subsection (1)(b) of section 3 of  
10 this act shall be the Vice President of the  
11 Federated States of Micronesia or the Vice  
12 President's designee. The allottee of the funds  
13 appropriated under subsection (2)(a) and (2)(b) of  
14 section 3 of this act shall be the Pohnpei Visitor's  
15 Bureau. The allottee of the funds appropriated  
16 under subsections (1) and (3) of section 4 of this  
17 act shall be the Governor of the State of Yap. The  
18 allottee of all other funds appropriated by this act  
19 shall be the President of the Federated States of  
20 Micronesia or the President's designee. The  
21 allottees shall be responsible for ensuring that  
22 these funds, or so much thereof as may be necessary,  
23 are used solely for the purpose specified in this  
24 act, and that no obligations are incurred in excess  
25 of the sum appropriated. The allottees of the funds
